Forfeitures - Open:

The Open Forfeiture Report was presented. The Chair invited comment or discussion. There being no further discussion, the Chair called for motions. Mr. Baldwin moved to notice for an immediate hearing those licensees whose forfeitures were not paid in a timely manner. Mr. Ibison seconded. The motion was put to a vote and carried with all in favor.

There were four (4) licenses issued since last meeting. A list was provided and no objections were made.

Investigators Report:

The staff investigator was absent so no report was made.

Executive Director's Report / Review:

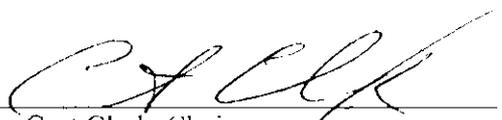
